### The Newcastle & Northumberland Local Council of the Year 2020

We are repeating the challenge again this year, particularly with all the excellent work being done during the current National Emergency.

We are anxious that good practice is recorded and shared, as well as being rewarded. Too often Local Councils are the subject of adverse comments and this is one way of redressing the balance.

The closing date is 30 September 2020.

There is no set format but please use email to set out your entry, and/or to attach further information. You should say why you consider your Council should be the Council of the Year.

The process is set out below

- A. Invitations are invited
- B. A panel of five is convened from members of the Committee, excluding any Councillor who is a member of one of the candidate Councils
- C. That the Panel awards Gold, Silver and Bronze prizes by 31 October 2020
- D. A modest trophy is given to each Council, being presented at one of their meetings by a senior member of the Committee
- E. Every Entry is given a certificate

### **Rural Community Energy Fund**

Rural communities can apply for up to £140,000 in funding to support renewable energy projects.

The Rural Community Energy Fund (RCEF) offers grants to help cover the costs of professional fees and consultancy when investigating whether a project is viable, and for creating a full business case to take projects forward. Examples of the types of technologies that can be used in renewable energy projects include solar panels, wind turbines, hydropower and heat pumps.

### The national NALC's Toilet Tax Survey

The national NALC have written to us as follows

Many thanks over recent months for promoting the NALC / BTA toilet tax survey:

- 541 responses received;
- Cornwall submitted the most responses with 12.8% of the overall submissions;
- 35% of respondents said they had incurred business rate fees of up to £1500 in the last financial year on their public conveniences;
- 58% of respondents said their councils had budgeted to pay NNDR on their public conveniences in the last financial year; &
- 99% of respondents said they supported the campaign to end the toilet tax on the statute book.

The resurrected Non Domestic Rating (Public Lavatories) Bill 2019-21 to finally end the toilet tax was re-commenced a few weeks ago in the Commons but Commons second reading was deferred from 30/3 due to coronavirus. A date for second reading in the Commons will be announced soon. I'll now contact the lead official at MHCLG to confirm when the date of second reading in the Commons will be.

The evidence gathered from the survey will be of use at later stages of the bill. Thanks,
