1: Welcome

- 1.1 The Chairman welcomed all present and with the agreement of the meeting invited Cllr Sanderson to address the meeting and take questions.
- 1.2 Cllr Sanderson updated the Committee on various re-cycling initiatives including seeking a bid for funding to extend the kerbside collection of glass for recycling within Northumberland.
- 1.3 In response to questions he said
 - Potholes remain a major problem. In some cases temporary emergency repairs are made but the preference is for more permanent repairs
 - The County Council is investigating methods of funding the landslip on the Rothbury
 Wheldon Bridge Road
 - He is part of the LA7 group of North East Council Leaders all of whom are very concerned about the rise in Covid cases
 - He was aware of rumours etc about the financial state of Advance Northumberland, but these did not reflect the reality. The Chief Officer will endeavour to set up an informal meeting for the County Committee on this topic. Action SER

- 8.2 During the course of discussion the following points were made
 - Like all voluntary organisations, Councils are finding it difficult to attract younger members
 - Younger members tend to join because of single issues and the task is to retain their interest to deal with other Local Council matters

- The Chief Officer was asked to organise a workshop for existing younger councillors to discuss how the Association could do more to engage with younger Councillors and members of our communities. Action SER
- The benefits of potential hybrid meetings allowing a greater range of parishioners to attend meetings, provided the technological hurdles can be overcome.
- The use of mentors for both new Councillors and Clerks

- 11.4 The Chief Officer was asked to clarify with the County Council whether non-consultation with Local Councils for Temporary Event Notices is based on national legislation/quidance or is local decision based on available resources. Action SER
- 11.5 The Chief Officer will press the County Council to arrange the discussion on cycle routes raised at the June meeting of the Town & Parish Liaison Working Group. Action SER
