#### **Civility and Respect Project**

NALC representatives attended the Assurance Board for the Civility and Respect Project on 5 April which focused on a review of the delivery proposals for the first phase of the project. The proposals are the result of several months of gathering requirements, uncovering and understanding issues related to bullying and harassment, the causes, effect and impacts of poor behaviour across our sector, and represent the first stage of the proposed action to start to tackle the issues. Phase one of the delivery proposal was unanimously approved by the project board, which is made up of representatives from NALC, Society of Local Council Clerks, One Voice Wales and county associations. Michelle Moss, project manager, will now start to work with the workstreams to plan the delivery of the tools and training for this phase.
