#### **Community Business**

The national NALC has launched *The Good Councillor's guide to community business*, in partnership with the Plunkett Foundation and Power to Change.

The guide for parish, town and community councillors sets out the principles of what a community business is and help local (parish and town) councils to consider whether this form of business could be appropriate in their community.

This publication contains 12 sections and aims to help councillors learn about the development stages of a community business, consider their role and that of the local council and also learn from examples of where collaboration has succeeded in other areas. Furthermore, seven case studies of local councils are included along with a resource list of useful websites, to facilitate further learning about this form of business.

### Potential Changes to the Planning Process

Outside the White Paper published in the summer, the MHCLG are consulting on technical changes.

The consultation seeks views on proposals for:

- a new permitted development right for a change of use to residential to create new homes
- measures to provide public service infrastructure more quickly through expanded permitted development rights and a new streamlined planning application process for hospitals, schools and prisons
- the approach to simplifying and consolidating existing permitted development rights following changes to the Use Classes Order
