### The County Council's Community Chest Scheme

Parish councils are able to apply to the Community Chest Scheme this year for the first time for support for projects that directly link to the Covid-19 pandemic.

Items of expenditure must be eligible under the scheme which typically funds items of equipment, capital works on land or buildings and one off hire costs. Applications can be up to 100% up to a maximum of £5,000.

The 100% up to £5,000 also applies to community and voluntary sector organs for specifically covid-19 related projects.

For non-Covid -19 projects, it is 75% but parish councils cannot apply.

The deadline is 2nd October with a further round deadline on 15 January. The Scheme is competitive and the panel decision is final.

All Parish, Town and Community Councils in Northumberland will hold elections in 6 May 2021. Contested elections will take place on Thursday 6 May 2021. The Association is working with the County Council's Elections Team and will be providing briefings later in the autumn.

#### **Website Accessibility**

The Association aims to produce some guidance for Member Councils in the near future, this has been delayed because of the need to deal with matters arising from the pandemic.

One point which has emerged is that Councils should avoid, if possible, uploading Word or Excel spreadsheets to the website. It seems that some hackers are able to use these as a way to get into a Council's computer. The advice is to use PDFs which are safer.
