Coronavirus

The Govt. has announced that from today - 24 February 2022

- "You will no longer be legally required to self-isolate if you test positive for COVID-19. New guidance will advise people who test positive to stay at home and avoid contact with other people.
- You will no longer be legally required to self-isolate if you are an unvaccinated close contact, and will no longer be advised to test for 7 days if you are a fully vaccinated close contact. New guidance will set out precautions for reducing risk to yourself and others.

This guidance will be updated shortly to include information on the above changes. You should continue to follow the guidance to keep yourself and others safe."

National Pay Negotiations

The national NALC have advised us that

"Further to previous information we have provided to you on the national pay negotiations, this is the latest information from LGA:

Unite's strike ballots close today in England and Wales and on 24

We have been informed that Unite's national local government committee will be meeting on Mon 28 February to discuss next steps. Therefore, there is little prospect of the pay deal being finalised before that date.

The National Employers continue to advise very strongly against implementing the pay offer before a formal collective deal has been finalised. To do so before the collective bargaining process has concluded would not only fragment the unity of the position held by all councils since the <u>full and final offer</u> was made last July, but it also leaves councils vulnerable to questions being asked by auditors as to why expenditure has been unnecessarily incurred in the absence of a national collective agreement. In addition, councils would need to consider very carefully the wider legal issues, including those arising out of the case of Kostal UK Limited v Dunkley (as explained in Advisory Bulletin 696)."

Parliamentary Constituency Boundaries

In June 2021, the Boundary Commission for England's (BCE) 2023 Review of Parliamentary Constituencies was published. This included a consultation to get feedback on proposed new boundary lines and constituency names.

BCE is now running a secondary consultation on their initial proposals.

To help promote this secondary consultation, BCE has produced a partner pack, available at the link below, containing a range of materials that can be used in various communication channels e.g. websites, bulletins, social media channels.

2022/2023 Council Tax Rebate

On 23 February, the Govt. sent guidance on the rebate to the billing authorities. It seems that the £150 rebate for Bands A-D will be paid direct to householders and will not be deducted from bills going out.

We anticipate more details will appear on the City and County Councils' website once they have had the opportunity to work through the guidance. This initial impression may therefore change.

We are not currently aware of any effect on the precepts paid to Parish Town and Community Councils by the City and County Councils.
