Legal Topic Notes

The national NALC's Legal Dept. have updated the procurement thresholds in Legal Topic Note (LTN) 87 (Procurement).

The UK government has issued these thresholds for the first time since Brexit and we have also removed EU references that are now not relevant to the content. While the LTN gives a basic overview, procurement is a niche area for which councils may need to take specialist advice when dealing with procurement matters.

They have also published a new LTN 89 (Sustainable energy and electric

vehicle (EV) charging), an area causing much interest to local councils. The LTN gives a broad overview and sets out the position for local councils and their powers in respect of generating or selling electricity, providing EV charging points on council premises including car parks and selling electricity back to the National Grid.

Both LTNs can be found in the member's area of the NALC website. The login is available to Member Councils on request to this office.
