#### **Brexit and North-East England**

The County Committee received a very informative briefing from Sarah McMillan (The Assistant Service Director - Policy at the County Council) and we are preparing a note for distribution to Member Councils in the near future.

Local Councils could assist residents by drawing attention to the closing date for applications to the EU Settlement Scheme. The limited information available to the County Council may indicate a lower number of applications than expected.

The scheme allows <u>EU</u>, <u>EEA</u> or Swiss citizens to apply to the <u>EU</u> Settlement Scheme to continue living in the UK after 30 June 2021.

Applications must be made before 30 June 2021.
