#### **Council Tax**

The Secretary of State has confirmed that the referendum principles will not apply to parish, town and community councils for 2022/2023.

The national NALC continue to press for a longer term announcement, rather than on a year-by-year basis.

We are starting to work through the paper, as are the national NALC, but would welcome any comments from colleagues please.

#### **Platinum Jubilee Flags**

The National Association of Civic Officers have circulated advice from the DDCMS on flags for HM The Queen's Platinum Jubilee. The request was prompted by the variety of designs currently being marketed.

The Department for Digital, Culture, Media and Sport is responsible for issuing guidance to all UK Government Buildings regarding flying the Union flag on designated days, and where appropriate when to fly the Union flag at half-mast.

With regard to your query, I contacted the College of Arms, the Crown body with responsibility for flags and other heraldic matters for England, Wales and Northern Ireland. Whilst the Royal Household has said via guidance on its website that the Emblem can be used on flags, the examples included in the guidance shows the Emblem on a plain background.

The College has advised that the version of the Union Flag with Emblem at the centre would first need to be considered by the Garter at Arms (principal adviser to the Sovereign of the United Kingdom with respect to flag-flying, ceremony and heraldry) before being submitted to HM The Queen for approval which is the usual practice with such flags.

The College recommends that the better flag would be the logo on a plain background. Please see guidance regarding the Emblem and its use, which you may wish to share with your colleagues.'
